Licenses Overview

The IRIS_GSSI is the Institutional Archive of the GSSI, in which bibliographic data and attachments of the publications and doctoral theses are stored.

The Products of the Research will be visible if they follow the Open Access policy agreed upon by accepting the Deposit Licence within the portal.

Publisher Policies

The copyright policy, which indicates whether the author can deposit an Open Access article on the institutional repository and in which version, may vary depending on the publisher and the journal in which the article is published, therefore an accurate search on the SherpaRomeo (link https://v2.sherpa.ac.uk/romeo/) website may be required.

To guarantee the rights of use of the publications, including that of deposit in an institutional archive, it is good practice that the author requests the publisher to insert a clause that allows him to make his publication visible in Open Access on the institutional repository, or ask the publisher to insert a clause that allows him to deposit: the <u>addendum</u>

If you have already signed a contract, you can ask the publisher for permission to deposit your publication on the university repository by sending a letter of request based on the model of those <u>prepared</u>.

If an article is published in an Open Access journal, it is almost always possible to archive the editorial version of the article.

Creative Commons License

Creative Commons (CC) licenses are based on copyright and apply to any copyrighted work. The fundamental prerequisite for being able to grant a work through a Creative Commons license is to be the owner of all the rights granted with

the license or to have an explicit authorization/request from the owner of the rights (for example the publisher).

Creative Commons (CC) licenses are based on copyright and apply to any copyrighted work. The basic prerequisite for being able to grant a work through a Creative Commons license is to be the owner of all the rights granted with the license or to have an explicit authorization / request from the owner of the rights (for example the publisher).

The Creative Commons licenses allow the author to define the rights that the author reserves towards the users of the document, according to the model "some rights reserved".

In the world of digital communication in which speeches at conferences, course texts, unedited writings are disseminated and shared in real time on the web, CC licenses allow the author to define the methods of use, the scope and its use.

Creative Commons licenses (currently version 4.0) are ideally structured in two parts: the first part indicates the freedoms granted by the author for his work; the second, on the other hand, sets out the conditions of use of the work itself.

The two freedoms are:

Sharing ► Freedom to copy, distribute or transmit the work

Reworking ► Freedom to re-adapt the work

The conditions of use of the work are four and each is associated with a graphic symbol in order to make it easier to recognize:

Symbol	Initial	Element	Description
ⓒ ⊕ ■	ВҮ	Attribution	It allows others to copy, distribute, display and make copies of the work and of the works derived therefrom as long as the indications are maintained.
	NC	NonCommercial	It allows others to copy, distribute, display and make copies of the work and derivative works from it for non-commercial purposes only.
	ND	No Derivative Works	It allows others to copy, distribute, display and make only identical copies of the work; derivative works are not allowed.

SA	Share Alike	It allows others to distribute
		derivative works of the work only
		under a license <u>identical or</u>
		compatible with that granted with
		the original work.

Each of these four clauses identifies a particular condition to which the user of the work must comply in order to be able to use it freely. The combination of these four clauses gives rise to the Creative Commons licenses in use:

© <u>0</u>	CC BY	This license allows reusers to distribute, remix, adapt, and build upon the material in any medium or format, so long as attribution is given to the creator. The license allows for commercial use.
© 1 0 as	CC BY-SA	This license allows reusers to distribute, remix, adapt, and build upon the material in any medium or format, so long as attribution is given to the creator. The license allows for commercial use. If you remix, adapt, or build upon the material, you must license the modified material under identical terms.
© PY ND	CC BY-ND	This license allows reusers to copy and distribute the material in any medium or format in unadapted form only, and only so long as attribution is given to the creator. The license allows for commercial use.
© (1) (S)	CC BY-NC	This license allows reusers to distribute, remix, adapt, and build upon the material in any medium or format for noncommercial purposes only, and only so long as attribution is given to the creator.
© S O BY NC SA	CC BY-NC-SA	This license allows reusers to distribute, remix, adapt, and build upon the material in any medium or format for noncommercial purposes only, and only so long as attribution is given to the creator. If you remix, adapt, or build upon the material, you must license the modified material under identical terms.
© S =	CC BY-NC-ND	This license allows reusers to copy and distribute the material in any medium or format in unadapted form only, for

noncommercial purposes only, and only so long as attribution is given to the creator.

CC Zero (CC0) is a public dedication tool, which allows creators to give up their copyright and put their works into the worldwide public domain. CC0 allows reusers to distribute, remix, adapt, and build upon the material in any medium or format, with no conditions.
